

MEMORANDUM.

TO M.N.R INTIMIDATION AND HARRASMENT. SEPT - OCT.

SEPT 24/04 5 PM.

MNR ENFORCEMENT OFFICER JIM GREENWOOD HAD A CONVERSATION WITH DWAYNE NICHOLS AT THE HAGERSVILLE QUARRY, STILL ATTEMPTING TO ENFORCE THE FRAUD OF APR 1/03 HAND DELIVERED LICENCE AND THE APR 14/03 SUSPENSION ORDER WITH 23 "PRE" OPERATING CONDITIONS.

DWAYNE NICHOLS MADE IT VERY CLEAR THAT THIS COMPANY HAD NO INTENTION OF COMPLYING WITH THIS CONSPIRED ILLEGAL FRAUD, AND THAT THE COMPANY WOULD PROCEED TO OPERATE THE QUARRY UNDER THE LEGITIMATE LICENCE AS O.M.B. DIRECTED AS SIGNED BY THE MINISTER MARCH 25, 2003.

MR. GREENWOOD STOPPED AT THE QUARRY WHERE GARY NICHOLS WAS WORKING ON THE SCALE HOUSE. HE RELATED THAT HE DID NOT HAVE A VERY GOOD CONVERSATION WITH DWAYNE NICHOLS THE PREVIOUS WEEK. GARY NICHOLS RESPONDED TO MR GREENWOOD, "YOUR NOT GOING TO HAVE A GOOD CONVERSATION WITH ME EITHER," AND THEN CLARIFIED TO MR. GREENWOOD THAT THIS FAMILY WOULD NOT BE PREVENTED FROM MAKING OUR LIVING, BY ANY LEVEL OF GOVERNMENT AND FURTHER MORE THIS QUARRY WOULD BE OPEN FOR BUSINESS THE FOLLOWING MONDAY MORNING.

MNR PICKUP DROVE BACK ACCESS ROAD TO QUARRY WORK AREA. GARY NICHOLS INQUIRED OF CONSERVATION OFFICER DAVE BEAVERS AND INSPECTOR EMMILIA KUISMA IF THIS WAS ANOTHER "COMPLAINT" VISIT. INSPECTOR KUISMA REPLIED, "NO WE ARE JUST OBSERVING." OUR PORTABLE CRUSHER HAD ARRIVED AT THAT POINT, AND MNR WAS REQUESTED TO MOVE THEIR PICKUP TRUCK OUT OF THE WAY.

MNR STAFF SAT OBSERVING OUR OPERATION FOR APPROXIMATELY 1 HOUR, THEN MADE A MOVE WITH THEIR TRUCK AND STARTED BACK TOWARD OUR CRUSHING AND PROCESSING AREA, AND I IMMEDIATELY TOOK AFTER THEM WITH THE CAT 966 LOADER I WAS OPERATING, WHERE I CUT THEM OFF AND STOPPED THEM JUST PAST OUR OPERATING IMPACT CRUSHER. WHEN I GOT OFF THE LOADER AND WALKED AROUND TO THEIR TRUCK, I NOTED THAT INSPECTOR KUJISKA HAD A PAD AND PENCIL IN HAND. AT THAT POINT IT IMMEDIATELY BECAME APPARENT WHAT THIS MNR OBSERVATION VISIT WAS ABOUT. THIS INTRUSION INTO OUR PROCESSING AREA WAS AN ATTEMPT TO GET A NAME OFF OF THE PROCESSING MACHINERY, SO THAT MNR COULD AGAIN WORK THEIR GESTAPO LIKE INTIMIDATION PROCESS THAT HAD WORKED SO WELL WITH MORCON CONSTRUCTION THE PREVIOUS YEAR, WHEN MNR THREATENED CHARGES AND PROSECUTION IF THEY PERFORMED WORK ON THE QUARRY PROPERTY. MORCON REMOVED THEIR MACHINERY WITHOUT FULFILLING THEIR CONTRACT, AND AS A RESULT WE HAD NO PRODUCT TO SELL AND THEREFORE COULD NOT OPERATE THE QUARRY.

HOWEVER THIS PLAN COULD NOT WORK THIS YEAR AS WE HAD PURCHASED OUR OWN CRUSHER IN ORDER TO AVOID A REPEAT PERFORMANCE BY MNR.

WHEN I WALKED OVER TO THE MNR PICKUP I ASKED THESE PEOPLE WHERE THEY WERE GOING, AND MR BEAVERS REPLIED, "WE ARE GOING BACK TO HAVE A LOOK." I THEN INFORMED THESE PEOPLE "NO YOU ARE NOT," AS YOU HAVE JUST CREATED A DANGEROUS SITUATION, WHEN YOU ENTERED OUR WORK AREA AND DROVE WITHIN 15' OF AN OPERATING IMPACT CRUSHER, NOW WE WANT YOU OUT OF HERE, AND GET OFF THE PROPERTY RIGHT NOW. MR BEAVERS REPLIED, WE HAVE A RIGHT TO BE HERE, ARE YOU DENYING US ACCESS, TO WHICH I REPLIED, THAT IS EXACTLY WHAT I AM DOING, AND FURTHERMORE SINCE MNR IS SO INTERESTED IN THIS QUARRY,

IF YOU COME BACK AGAIN, I WILL DROP A BUCKET OF STONE ON YOUR PICKUP TRUCK AND YOU CAN HAUL THAT BACK TO AYLMER WITH YOU.

MY SON DWAYNE THEN ARRIVED ON THE SCENE, AND ALSO PROCEEDED TO THOROUGHLY CHEW THESE PEOPLE OUT FOR THE ARROGANT INTIMIDATING PERFORMANCES THAT WE HAVE RECEIVED FROM MNR.

WE AGAIN CLARIFIED TO MNR STAFF, THAT WE WOULD TOLERATE NO FURTHER INTIMIDATION, HARASSMENT OR INTERFERENCE WITH OUR BUSINESS.

MNR STAFF THEN RELUCTANTLY LEFT OUR PROPERTY, WHERE THEY PARKED JUST OUTSIDE THE ENTRANCE TO THE QUARRY. THEY SPENT THE REST OF THE DAY OBSERVING OUR ACCESS ROAD UNTIL A TRUCK CAME IN AND WAS LOADED AND LEFT APPROXIMATELY 3 PM. WHAT A PATHETIC WASTE OF TAX DOLLARS.
