The Law Society of Upper Canada CEO Robert Lapper and Bencher Directors

Dear Mr. Lapper and Elected Benchers:

This letter concerns my previous requests to investigate the Misfeasance and Criminal activities to Professional Misconduct of Government and 6 previously named Ontario Province employed Crown Prosecutor Solicitors, to which there has been no response from the Law Society of Upper Canada since the brush off response of September 23, 2013 from Law Society of Upper Canada Director Zeynep Onen.

In all of these 2015 – 2016 requests to investigate, there was provided Ministry of Natural Resources documentation, Factums, and submissions to the Courts which clearly identified Fabricated False Pretense Submissions of various Crown Unlawful Misrepresentations resulting in a Fraud on the Courts to Obstruction of Justice in contravention of the Criminal Code of Canada and the "Rule of Law" which for the most part, this Crown evidence was accepted without question by Government Patronizing Justices of the Courts.

The Crown manipulated this Unlawful Enforcement of Fraud through various Tribunals and Courts in Contempt of Court to the Superior Court Judicial Review Declatory Decision and Orders of June 15, 2006. **Not Appealed.** 

To the conclusion of this Miscarriage of Justice Farce after 13 years, 8 months on June 22, 2016 when MNR charges were Quashed and Dismissed by His Honour Judge Ken Lentz.

I have carefully reviewed the Legislation of the Law Society Act and find <u>no</u> provisions in the Legislation to <u>exempt</u> government employed Crown Prosecutors or <u>any</u> Solicitors from compliance to the Law Society of Upper Canada Legislation. If there are such provisions somewhere, please identify, if not, I suggest that S.-15-1 of our Charter "Equality Before the Law" should apply. Due to the extended non response from the Law Society of Upper Canada to requests to investigate dated September 3, October 1, December 16, 2015 and April 11, 2016 and fax letters of October 11, and November 11, 2016, it would appear that the Staff and Elected Bencher Directors of the Law Society have made a Decision to become a party to this Professional Misconduct and committed to this extended Criminal Abuse of Process, non compliance to Legislation to Obstruction of Justice and Miscarriage of Justice to cover up and protect the Misfeasance, Misrepresentation, and Professional Misconduct of Crown Solicitors as identified by their own Documentation to provide a Fraud on the Courts and place the Administration of Justice into Disrepute, as identified in my requests to investigate, now on Website: www.injusticecanada.com

This Criminal Misfeasance of the Crown Solicitors and the Courts to cover up for the Unlawful Fabrications of MNR Staff, and Ministry of the Attorney General Solicitor cover up have now been widely circulated across Canada.

Please be advised that if there is No Immediate Response to this Final Appeal for Justice, this matter shall be directed to the Commissioner of the Ontario Provincial Police Head Office Orillia, Criminal Investigations Branch with a request for investigation to appropriate charges to the Government of Ontario Ministry of Natural Resources and Forestry and the Ministry of the Attorney General, its Officials, Officers, and Solicitors for the Criminal Enforcement of Extortion and Fraud of the Legislation of the Aggregate Resources Act for the past 13 year, 8 months to MNR Licence 103717, Nichols Gravel Limited and Shareholders Gary, Margaret and Dwayne Nichols.

In particular we shall request that the Administration of the Law Society of Upper Canada be investigated for the failure to enforce the Legislation of the Law Society Act to requests to investigate dating back to April 2007 the Misfeasance and Professional Misconduct of Ontario Crown Prosecutor Solicitors, and the last requests to investigate in letters dated September 3, October 1, and December 16, 2015, which in fact, clearly identified the False Pretense Submissions by Crown Solicitor and Professional Misconduct to Fraud on the Courts to Defeat Justice.

Upon receiving <u>no</u> response to September, October and December 2015 letters, then on April 11, 2016 a request for investigation was sent directly to CEO Robert Lapper and <u>all</u> elected Bencher Directors of the Law Society which again received <u>no</u> response.

Fax letters dated October 11 and November 11, 2016 sent to <u>all</u> Law Society of Upper Canada Bencher Directors and <u>again</u> received <u>no</u> response, which now confirms a huge extended cover up of the Criminal Misfeasance and Professional Misconduct of the 6 named Government Solicitors.

In this respect the Staff and elected Bencher Directors have now become a party to this extended Criminal Corrupted Cover up since December 2015 and we shall request further investigation of Law Society of Upper Canada Staff and Benchers under Criminal Code c -46 "As Accessory After the Fact" in order to suppress and cover up Solicitor Professional Misconduct, contrary to the Legislation of the Law Society Act.

Please further be advised that a Press Release will also go out at the same time as the O.P.P. request to investigate to all of the News Media, to inform of our request for investigation of the Administration of the Law Society, the Crown Solicitors so named to the Law Society Act Legislation and also its Staff and Bencher Directors for failure to comply with Legislation to protect the Administration of Justice, The Rule of Law and the Public Interest.
