Dear Madam:

It again becomes necessary for clarification to your last brush off letter of response, December 15, 2016, on behalf of the Law Society of Upper Canada and C.E.O. Mr. Robert Lapper, and Bencher Directors.

Firstly, a correction of date is required, last paragraph, first page your letter, to the last L.S.U.C. response date from Ms. Onen.

The last response was dated, September 23, 2013, not September 23, 2016, as in your letter.


